

**TVS SRICHAKRA LIMITED Policy for Determination of materiality of Events / Information**  
**{Pursuant to Regulation 30(4)(ii) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015}**

**Objective**

In terms of Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“Listing Regulations”) read with SEBI’s Circular bearing reference CIR/CFD/CMD/4/2015 dated 9<sup>th</sup> September 2015, the Board of Directors (the “Board”) of TVS SRICHAKRA LIMITED (“TSL” or “the Company”) has adopted this Policy for determination of materiality based on the criteria mentioned in the Listing Regulations (“Material Information”) such that required information can be promptly disclosed to the Stock Exchanges, as required under Listing Regulations

**Authorised Persons**

The materiality or otherwise, of an information or event in terms of the Listing Regulations will be **jointly determined by any of the two, i.e. Executive Vice Chairman, Managing Director, Chief Financial Officer and Company Secretary of the Company, Key Managerial Person (KMPs) of the Company (“Authorised Persons”)** in consultation with the concerned Department Head(s) or Senior General Manager(s) / General Manager(s) as the case may be.

The authorized persons will also decide the appropriate period / stage at which the disclosure is to be filed with the stock exchanges and details that may be filed.

**The guidelines to ascertain materiality of an event or information (Regulation No.30 (4)(i) of the Listing Regulations) :**

The Company shall consider the following criteria for determination of materiality of events / information :

- a) the omission of an event or information, which is likely to result in discontinuity or alteration of event or information already available publically;  
or
- b) the omission of an event or information is likely to result in significant market reaction if the said omission came to light at a later date;
- c) In case where the criteria specified in sub-clauses (a) and (b) are not applicable, an event / information may be treated as being material if in the opinion of the Board of Directors of Company, the event / information is considered material.

Materiality will be determined on a case to case basis depending on specific facts and circumstances relating to the information / event. In order to determine whether

a particular event / information is material in nature, „quantitative“ and qualitative factors also as the case may be criteria will be applied.

In circumstances where “quantitative” test may not be applicable or cannot be applied, a “qualitative” or a “subjective”, criteria as under will be applied to determine materiality.

#### Deemed material events or information

Events or information specified below will be deemed to be material events / information and will be disclosed irrespective of application of any quantitative or qualitative materiality thresholds and without any application of the guidelines for materiality as specified in sub-regulation (4) of regulation (30):

1. Acquisition(s) (including agreement to acquire), Scheme of Arrangement (amalgamation / merger / demerger / restructuring), or sale or disposal of any unit(s), division(s) or subsidiary of the Company or any other restructuring.

Explanation.- For the purpose of this sub-para, the word 'acquisition' shall mean,-

- (i) acquiring control, whether directly or indirectly; or,
  - (ii) acquiring or agreeing to acquire shares or voting rights in, a company, whether directly or indirectly, such that –
    - (a) the Company holds shares or voting rights aggregating to five per cent or more of the shares or voting rights in the Company, or;
    - (b) there has been a change in holding from the last disclosure made under sub-clause (a) of clause (ii) of the Explanation to this sub-para and such change exceeds two per cent of the total shareholding or voting rights in the Company.
2. Issuance or forfeiture of securities, split or consolidation of shares, buyback of securities, any restriction on transferability of securities or alteration in terms or structure of existing securities including forfeiture, reissue of forfeited securities, alteration of calls, redemption of securities etc.
  3. Revision in Rating(s).
  4. Outcome of Meetings of the board of directors: The Company shall disclose to the Exchange(s), within 30 minutes of the closure of the meeting, held to consider the following:
    - a) dividends and/or cash bonuses recommended or declared or the decision to pass any dividend and the date on which dividend shall be paid / dispatched;

- b) any cancellation of dividend with reasons thereof;
  - c) the decision on buyback of securities;
  - d) the decision with respect to fund raising proposed to be undertaken
  - e) increase in capital by issue of bonus shares through capitalization including the date on which such bonus shares shall be credited / despatched;
  - f) reissue of forfeited shares or securities, or the issue of shares or securities held in reserve for future issue or the creation in any form or manner of new shares or securities or any other rights, privileges or benefits to subscribe to;
  - g) short particulars of any other alterations of capital, including calls;
  - h) financial results;
  - i) decision on voluntary delisting by the Company from stock exchange(s).
5. Agreements (viz. shareholder agreement(s), joint venture agreement(s), family settlement agreement(s) (to the extent that it impacts management and control of the Company), agreement(s) / treaty(ies) / contract(s) with media companies) which are binding and not in normal course of business, revision(s) or amendment(s) and termination(s) thereof.
6. Fraud/defaults by promoter or key managerial personnel or by the Company or arrest of key managerial personnel or promoter.
7. Change in directors, key managerial personnel (Managing Director, Chief Executive Officer, Chief Financial Officer , Company Secretary etc.), Auditor and Compliance Officer.
8. Appointment or discontinuation of share transfer agent.
9. Corporate debt restructuring.
10. One time settlement with a bank.
11. Reference to BIFR and winding-up petition filed by any party / creditors.
12. Issuance of Notices, call letters, resolutions and circulars sent to shareholders, debenture holders or creditors or any class of them or advertised in the media by the Company.

13. Proceedings of Annual and extraordinary general meetings of the Company.
14. Amendments to memorandum and articles of association of the Company, in brief.
15. Schedule of Analyst or institutional investor meet and presentations on financial results made by the Company to analysts or institutional investors;

The Policy shall be applied to determine the materiality in respect of the following types of event / information, as laid down under Para B of Part A of Schedule III to the New Regulations and described in detail vide Annexure I of SEBI's circular dated September 9, 2015, on Regulation 30 of the New Regulations.

**Events which shall be disclosed upon application of the guidelines for materiality referred sub-regulation (4) of regulation (30)**

1.	Commencement or any postponement in the date of commencement of commercial production or commercial operations of any unit / division.	Impact exceeding 10% of Turnover of the Company as per the last audited Balance Sheet
2.	Change in the general character or nature of business brought about by arrangements for strategic, technical, manufacturing or marketing tie-up, adoption of new lines of business or closure of operations of any unit / division (entirety or piece-meal).	Impact exceeding 10% of Turnover of the Company as per the last audited Balance Sheet
3.	Capacity addition	Exceeding 10% of the existing capacity.
4.	Product Launch	Any new line of products contributing to more than 10% of Turnover of the Company as per the last audited Balance Sheet
5.	Awarding, bagging / receiving, amendment or termination of awarded / bagged orders / contracts not in the normal course of business.	Impact exceeding 10% of Turnover of the Company as per the last audited Balance Sheet

Sl. No.	Event / Information	Threshold
6.	Agreements (viz. loan agreement(s) (as a borrower) or any other agreement(s) which are binding and not in normal course of business) and revision(s) or amendment(s) or termination(s) thereof.	Impact exceeding 10% of Turnover of the Company as per the last audited Balance Sheet
7.	Disruptions of operation of any one or more units or division of the listed entity due to natural calamity (earthquake, flood, fire etc), force majeure or events such as strikes, lockouts etc.	Estimated impact of 10% or more of the turnover of the Company as per the last audited Balance Sheet in case of disruption of operations due to natural calamity
8.	Effect(s) arising out of changes in the regulatory framework applicable to the listed entity	Impact of 10% or more to the turnover as per the last audited Balance Sheet.
9.	Litigation(s) / dispute(s) / regulatory action(s) with impact.	Outcome of litigation, dispute, and regulatory action is likely to have an impact of not less than 10% of the turnover as per the last audited Balance Sheet or 20% change in profit before tax of preceding financial year, whichever is lower
10.	Fraud / defaults etc by Directors (other than Key Managerial Personnel) or employees of listed entity.	As per limits prescribed under the Companies Act, 2013 from time to time.
11.	Options to purchase securities including any ESOP / ESPS Scheme.	Exceeding 1% of the post issuance / allotment paid up share capital
12.	Giving of guarantees or indemnity or becoming a surety for any third party.	As per limits prescribed under the Companies Act, 2013 from time to time or Guarantees or indemnity or becoming surety for sum not less than INR 50 Crores, whichever is lower.

Sl. No.	Event / Information	Threshold
13.	Granting, withdrawal, surrender, cancellation or suspension of Key Licenses or regulatory approvals.	Impact exceeding 10% of the turnover as per the last audited Balance Sheet of the Company

Any other information / event viz. major development that is likely to affect business, e.g. emergence of new technologies, expiry of patents, any change of accounting policy that may have a significant impact on the accounts, etc. and brief details thereof and any other information which is exclusively known to the Company which may be necessary to enable the holders of securities of the Company to appraise its position and to avoid the establishment of a false market in such securities.

Threshold : Impact exceeding 10% of Turnover of the Company as per the last audited balance sheet or 15% of profit before tax as per last audited balance sheet whichever is applicable.

Without prejudice to the generality of above, the Company may make disclosures of event / information as specified by the Board from time to time.

#### **Timing of disclosure**

All material events / information will be disclosed as promptly as practicable as per the provisions of Regulation 30 read with SEBI's Circular bearing reference CIR/CFD/CMD/4/2015 dated 9<sup>th</sup> September 2015.

#### **General**

Where the terms of this policy differ from any existing or newly enacted law, rule, regulation or standard governing the Company, the law, rule, regulation or standard will take precedence over this policy until such time as this policy is changed to conform to the law, rule, regulation or standard.

The material events / information, disclosed to the Stock Exchanges in line with the above policy, shall be placed before the Board, at its next meeting for Board's information.
